ORDER:-

In the G.O. 1st read above, the panel of eligible Assistant Directors of Agriculture for promotion to the post of Deputy Director of Agriculture for the panel year 2014-15 was prepared including the names of Sri N. Venkateswarlu and Sri I. Murali at Sl.No.12 (RP 46) and Sl.No.22 (RP- DA RP 56). Later in G.O.Rt.No.720 & 722, dt.09.10.2015 of Agri. & Coop. (Vig. I) Dept., certain charges were framed against Sri N. Venkateswarlu and Sri I. Murali and accordingly, their cases were not considered for promotion as Deputy Directors of Agriculture as per the orders issued in G.O.Ms.No.104, General Administration (Ser. C) Dept., dt.16.12.1990.

- 2. In the Govt. Memo. 3rd read above, orders were issued dropping further action against Sri N. Venkateswarlu and Sri I. Murali, Assistant Directors of Agriculture along with others.
- 3. In the representations 4th read above, Sri N. Venkateswarlu and Sri I. Murali have submitted that the disciplinary proceedings pending against them was dropped vide Govt. Memo. Dt.24.07.2017 and therefore, requested to promote them as Deputy Directors of Agriculture since their names were already cleared by the D.P.C., for the panel year 2014-15.

4. Accordingly, under Rule 10(a) of the A.P. State & Subordinate Service Rules, 1996, the following Assistant Directors of Agriculture are hereby appointed by transfer on promotion to the post of Deputy Directors of Agriculture notionally on par with their juniors respectively during the panel year 2014-15 in the scale of pay of Rs.49,870/- – Rs.1,00,770/- plus usual allowances admissible under the rules in force from time to time.

State and Sub-ordinate Service Rules, 1996 read with G.O.Ms.No.145, General Administration (Ser. D) Department, Dt.15.06.2004.
