### ORDER:

Whereas in the Anti Corruption Bureau trap case, the Special Judge for ACB Cases, Kurnool pronounced in his judgment in C.C.NO.39/2014, dated: 28.07.2017 convicting that the Accused Officer Sri V. Vengal Reddy, formerly as Agricultural Officer, Holagonda Mandal, Kurnool District now presently working as Agricultural Officer,(STL), Yemmiganoor, Kurnool dist. and sentenced him to undergo rigorous imprisonment for a period of two years and also pay fine of Rs.1000/- (Rupees One thousand only) for the offence punishable u/s.7 of the P.C.Act ,1988 and two years rigorous imprisonment and a fine of Rs.1000/- (Rupees one thousand only for offence punishable Under Section 13(1)(d) of PC Act, 1988 and in default of payment of fine amount, the Accused Officer shall undergo simple imprisonment for a period of further one month vide reference 5<sup>th</sup> read above.

- 2. And whereas it is considered that the conduct of the said Sri V. Vengal Reddy, formerly as Agricultural Officer, Holagonda Mandal, Kurnool District now presently working as Agricultural Officer,(STL), Yemmiganoor, Kurnool dist. which has led to his conviction, is such as to warrant the imposition of a major penalty of dismissal from service.
- 3. Now, therefore, in exercise of the powers conferred by rule 25 (i) of the Andhra Pradesh Civil Services (CC&A) Rules, 1991 read with rule x of Rule 9 of A.P.C.S. (CC&A) Rules, 1991 and in terms of G.O in the references 6<sup>th</sup> and 7<sup>th</sup> read above, Government hereby impose the penalty of dismissal from service against Sri V. Vengal Reddy, formerly as Agricultural Officer, Holagonda Mandal, Kurnool District now presently working as Agricultural Officer,(STL), Yemmiganoor, Kurnool dist.

4. The Special Commissioner of Agriculture, A.P., Guntur shall take further necessary action accordingly.
