ORDER:-

In the G.O. 3rd read above, orders were issued approving the guidelines for supply of 6000 Tractors to the farmers under subsidy in the name of "Rythu Radham Programme" and allocated Rs.125.00 Crores from the State Development Plan from Farm Mechanisation Scheme for the year 2017-18. The following is one of the Guidelines at SI.No.(2):

"Subsidy allowed for 4WD tractor 35 HP and above with other equipment like reversible hydraulic mould board plough, rotovator, shredder, mulcher, rotopuddler is of Rs.2,50,000/- and for 2 WD tractor 35 HP with above other equipment is of Rs.2,00,000/-".

2. In the reference 4th read above, the Special Commissioner of Agriculture, A.P., Guntur has proposed certain insertion in the guidelines at para 2 and requested to insert in the guidelines at para 2 as any one of the equipment is optional and subsidy for 2 WD Tractor is Rs.1.50 lakhs and subsidy for 4 WD is Rs.2.00 lakhs and the subsidies already mentioned for 2WD and 4 WD with any one of the equipment will remain same as ordered in the above G.O.

3. Government after careful examination, hereby ordered to insert the following after para 2 of the Guidelines issued vide G.O. 3rd read above:

"Subsidy also allowed for 4 WD tractor 35 HP and above without equipment is of Rs.2,00,000/- and for 2 WD tractor 35 HP without equipment is of Rs.1,50,000/- and the subsidies already mentioned for 2 WD and 4 WD with any one of the equipment will remain same as ordered in the G.O. 363 and it is optional to the farmers."

4. The Special Commissioner of Agriculture, A.P., Guntur shall take necessary action accordingly.
