ORDER:-

In the G.O. 1st read above, orders were issued for preparing the list of names of suitable Deputy Directors of Agriculture for including in the panel of Deputy Directors of Agriculture for promotion to the category of Joint Director of Agriculture for the panel year 2011-12 and the Roster Point No.31 was carried forward and thereafter no D.P.Cs., were convened and no panels for the posts of Joint Director of Agriculture were prepared for the panel years 2012-13 and 2013-14.

2. Later, at the time of preparation of panel of the eligible Deputy Directors of Agriculture for promotion to the category of Joint Director of Agriculture for the panel year 2014-15, the name of Smt. Gousia Begum, who is Hearing Impaired Woman and who was promoted as Deputy Director of Agriculture notionally with effect from 23.04.2012 on par with her junior, was examined and not considered since she has not completed minimum period of 3 years of service as Deputy Director of Agriculture as per G.O.Ms.No.230, G.A. (Ser. A) Dept., dt.31.05.2014.

- Smt. Gousia Begum has represented that in G.O.Ms.No.46, Agri. & Coop. (Agri. I) Dept., dt.31.08.2015, (13) Deputy Directors were promoted as Joint Directors, in which the Roster Point No.31 (CF Hearing Handicapped) was also filled up from open category instead of further carry forward of Roster Point No.31, erroneously due to inadequate application of rule 22 of A.P. State & Subordinate Service Rules against to the spirit of the orders issued in G.O.Ms.No.18, S.W. (SW. ROR. I) Dept., dt.17.02.2005 and G.O.Ms.No.449, G.A. (Ser.D) Dept., dt.15.09.2009. She has submitted that each category of disabled have to be treated as a separate community after trifurcation and if no suitable candidate is available from specific category it should be carry forwarded to the next recruitment year but should not fill up in open seniority or other category of disabled person. Adequacy should not be calculated taking the total disabled persons working in the Unit of appointment ignoring trifurcation. Smt. Gousia Begum has, therefore, requested to consider her case for promotion as Joint Director of Agriculture against Roster Point No.31 of the Cycle I (Hearing Handicapped). also furnished certain copies of G.Os., wherein orders were issued relaxing the required minimum service in favour of certain Officers for promotion to the higher categories.
- 4. The Director of Agriculture has requested the Government on the request of the individual, to clarify on RP 31 PH (HH) considered for Open category during the panel year 2014-15, keeping in view that the RP 31 was carried forward during the panel year 2011-12 and later no D.P.Cs., were convened and no panels were prepared for the panel years 2012-13 and 2013-14.
- 5. In the G.O. 3rd read above, orders were issued orders relaxing the minimum qualifying service prescribed in G.O.Ms.No.230, General Administration (Ser. A) Department, dt.31.05.2014 in favour of Smt. Gousia Begum, Deputy Director of Agriculture (Hearing Handicapped), for inclusion of her name at Roster Point 31 (Hearing Handicapped) in the panel of Deputy Director of Agriculture for promotion as Joint Director of Agriculture for the panel year 2014-15 by convening Review Departmental Promotion Committee.
- 6. Government after careful examination of the entire matter and after consideration of recommendations of the Review Screening Committee, hereby decided to include the name of Smt. Gousia Begum, Deputy Director of Agriculture at R.P. 31 (HH) in the panel of Deputy Directors of Agriculture for promotion to the category of Joint Directors of Agriculture for the panel year 2014-15 above the name of Sri J. Murali Krishna, issued in the G.O. 2nd read above.

- 7. Accordingly, Government hereby include the name of Smt. Gousia Begum, Deputy Director of Agriculture at R.P. 31 (HH) in the panel of Deputy Directors of Agriculture for promotion to the category of Joint Directors of Agriculture for the panel year 2014-15 above the name of Sri J. Murali Krishna, issued in the G.O. 2nd read above.
- 8. Accordingly, Smt. Gousia Begum is hereby promoted notionally as Joint Director of Agriculture for the panel year 2014-15 on par with Sri J. Murali Krishna, who was promoted as Joint Director of Agriculture in the pay scale of Rs.56,870/- - Rs.1,05,870/- plus usual allowances admissible under the rules in force from time to time.
- 9. Consequent on promotion as Joint Director of Agriculture, Smt. Gousia Begum is posted as Joint Director of Agriculture, Eluru, West Godavari District.
- The above orders are subject to directions / outcome of O.As. / W.Ps. / W.As. / R.Ps. / C.As. / S.L.Ps., etc., if any, pending before the Tribunal / any other Courts, etc.
- 11. The Special Commissioner of Agriculture, A.P., Guntur shall take further necessary action in the matter accordingly.
