## ORDER:

The Principal Secretary to Government, Agriculture & Co-operation Department, State of Telangana in the letter 2<sup>nd</sup> read above has submitted the proposal for Inter State Transfer in respect of Smt. Bhavani, AEO, Gr.II, Pitlam Circle of Pitlam Mandal, O/o ADA (R), Bichkunda, Kamareddy District and requested the Government of Andhra Pradesh to issue appropriate orders for transfer to Vizianagaram District of Andhra Pradesh State on spouse grounds as per guidelines issued in Circular Memo. No. 9940/ SPF.MC/2015, dt.07.08.2017, since Sri K. Damodara Rao (the Spouse of Smt. M. Bhavani, AEO, Gr.II,) is working as AEO on regular basis in Merakamudidam (M) under the control of ADA (R) Cheepurupalli, Vizianagaram District from 02.08.2012 and as per the study certificates, the spouse of the applicant is belongs to the State of Andhra Pradesh.

The Special Commissioner of Agriculture, AP, Guntur in the letter 3<sup>rd</sup> read above has submitted the Inter-State transfer proposal of the above individual along with the District wise vacancy position of AEOs in the State of Andhra Pradesh and requested to consider the Inter State transfer of the above individual on spouse grounds, as that Sri K. Damodara Rao, Husband of Smt. M. Bhavani is also working in Agriculture Department as AEO, Merakamudidam Mandal of Cheepurupalli Sub-Division of Vizianagaram District, State of Andhra Pradesh.
- 3. In the letter 4<sup>th</sup> read above, Government of Andhra Pradesh have issued No Objection Certificate to the Government of Telangana and requested to relieve the services of above individual from the State of Telangana to State of Andhra Pradesh on spouse grounds.
- 4. In the G.O. 5<sup>th</sup> read above, the Government of Telangana, Hyderabad have issued orders for Inter-State transfer of Smt. M. Bhavani, AEO, Gr-II, Pitlam Mandal, O/o the ADA (R) Bichkunda, Kamareddy District, Telangana from the State of Telangana to the State of Andhra Pradesh on spouse grounds, subject to assign last rank in the seniority in the AEO cadre in terms of the orders issued in the reference 1<sup>st</sup> read above. The Commissioner

of Agriculture, Telangana State, Hyderabad vide reference 6<sup>th</sup> read above has relieved the services of the above individual on 18.03.2019 with a direction to report before Government of Andhra Pradesh for further postings.

In the circumstances explained by the Government of Telangana, Hyderabad in the G.O. 5<sup>th</sup> read above and Special Commissioner of Agriculture, AP, Guntur in the letter 3<sup>rd</sup> read above, the matter has been examined in detail as per the Circular Memo 1<sup>st</sup> read above and also verification of other parameters as per said Circular Memo, Government hereby permit the Special Commissioner of Agriculture, AP, Guntur to accept the Inter-State transfer in respect of Smt. M. Bhavani, AEO, Gr.II, Pitlam Circle of Pitlam Mandal, O/o ADA ( R), Bichkunda, Kamareddy Dist, State of Telangana to State of Andhra Pradesh on Spouse grounds with immediate effect, as per provisions contained in the Circular Memo 1<sup>st</sup> read above, subject to condition that, she shall take last rank next to the last regular AEOs in the new State and forego her seniority in the existing State.
- 6. The individual effected in this Inter-State transfer is not entitled for any Travelling Allowance or Dearness Allowance as per the guidelines issued in the Circular Memo  $\mathbf{1}^{\text{st}}$  read above, as the transfer is ordered as per her request.
