P. Civil Service (Conduct) Rules, 1964.

Coromandal Agro & Marine Agencies(Supplier), Nellore towards pending subsidy portion under Farm Mechanization during the year 2012-2013 as per the conditional affidavit submitted by the firm, hiding the facts even though specific instructions were issued vide their Memo No.FM(1)243/13, dated:19.07.2013 by the Commissioner and Director of Agriculture, AP, Hyderabad to stop payment to M/s Rekha Agriplus, who has manufactured Taiwan Sprayers under Farm Mechanization Scheme.
