## ORDER:

In the reference 1<sup>st</sup> read above the Commissioner & Director of Agriculture, Hyderabad has stated that, the GOI, have released an amount of Rs. 2098.812/- lakhs (Rupees twenty Crores ninety eight lakhs eighty one thousands and two hundreds only) in favour of Government of Andhra Pradesh exclusively for General farmers for implementation of seed Village Scheme during 2013-14 and vide G.O.Rt.677 Fin (EAC) Dept., dt.10.03.2014 and G.O.Rt.No.226, A&C (Agri.V) Dept, dt.11.03.2014 the BRO and Administrative sanction was issued by the Government of Andhra Pradesh and vide his office Ir.dt.22.03.2014 DTO authorization was issued and it was released to districts for incurring expenditure under SVP at the fag end of the year i.e., during March 2014. Due to budget freeze order the bills submitted by JDAs were returned and amount was lapsed.

The Commissioner & Director of Agriculture, Hyderabad in the reference 1<sup>st</sup> read above has requested to reissue the Budget Release Order and Administrative sanction for an amount of Rs.1745.92- lakhs (Rupees Seventeen Crores Forty Five Lakhs and Ninety Two Thousands Only) for clear the dues of expenditure incurred under Seed Village Scheme organized during 2013-14 in relaxation of quarterly regulation orders.

3. In the reference 2<sup>nd</sup> read above, Government in Finance (Expr. A&C) Department, have issued Budget Release Order for an amount of Rs17,45,90,000/- (Rupees Seventeen Crores Forty Five Lakhs Ninety Thousands Only) to the Commissioner & Director of Agriculture, A.P., Hyderabad under plan from the Budget Estimate Provision 2014-15 as additional funds an amount of Rs.1745.90 lakhs in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds in final B.E 2014-15 for implementation of Seed Village Scheme from the head of account indicated therein.

4. In pursuance of the above orders, Government hereby accord administrative sanction for an amount of Rs17,45,90,000/- (Rupees Seventeen Crores Forty Five Lakhs Ninety Thousands Only) to the Commissioner & Director of Agriculture, A.P., Hyderabad under plan from the Budget Estimate Provision 2014-15 as additional funds an amount of Rs.1745.90 lakhs in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds in final B.E 2014-15 for implementation of Seed Village Scheme under the head of account indicated in the G.O. read above.
