The Finance (EBS-II-A-C-AHFCS-E) Department, in the reference 2nd read above, have issued B.R.O. for an amount of Rs.63,17,00,000/- (Rupees sixty three crores and seventeen lakhs only) under plan from the BE provision 2014-15 towards meeting the expenditure for implementation of Normal RKVY and Sub-Schemes of RKVY under the Heads of Account mentioned therein.
