In the letter 1st read above, the Director of Agriculture, Andhra Pradesh, Hyderabad has requested the Government to issue Budget Release Order and Administrative Sanction for an amount of Rs. 182,61,00,000/- (Rupees One hundred Eighty Two Crores and Sixty One Lakhs only) for implementation of RKVY during 2015-16 over and above BEs 2015-16 in relaxation to quarterly regulation and treasury control under Centrally Assisted Plan Scheme of RKVY 2015-16.

2. In the G.O. 2nd read above, the Finance (FMU-A-C-AHDD&F,CS) Department, have issued B.R.O. for an amount of Rs. 182,60,00,000/- (Rupees One Hundred Eighty Two Crores and Sixty Lakhs only) Plan from the BE provision 2015-16 along with additional funds sanctioned in relaxation of Treasury Control and Quarterly Regulation orders by re-appropriation of funds by adjustment in overall savings of B.E. 2015-16 towards meeting the expenditure under the Scheme Rashtriya Krishi Vikas Yojana (RKVY).

Accordingly, Government, after careful examination, hereby accord administrative sanction for an amount of Rs. 182,60,00,000/- (Rupees One Hundred Eighty Two Crores and Sixty Lakhs only) Plan from the BE provision 2015-16 in relaxation of quarterly regulation orders towards meeting the expenditure for implementation of various projects under RKVY during the current financial year 2015-16 against the Heads of Accounts as detailed below.-
