## <u>O R D E R</u>:-

G.O.MS.No. 7

In the G.Os. 1s t and 2nd read above, the case of Sri S. Ratnachari for promotion as Deputy Director of Agriculture was differed during the panel years 2010-11 and 2011- 12 due to pendency of disciplinary case and his juniors Sri S. Bapu Reddy, and Balu Naik, were considered for promotion and accordingly promoted to the post of DDA's during the panel years 2010-11 and 2011-12 respectively. Later, in the G.Os. 3 rd and 4th read above, Sri S. Ratna Chari was promoted as Deputy Director of Agriculture on adhoc basis pending disciplinary action in terms of orders issued in G.O.Ms.No.257, General Administration (Ser. C) Department, dt.10.06.1999 as per the orders of Hon'ble A.P. Administrative Tribunal and posted as Deputy Director of Agriculture (PP), Office of the Commissioner & Director of Agriculture. Later, in Govt.Memo.No.14676/Vig.I/A1/2008, Agriculture & Cooperation (Vig. I) Department, dt.21.03.2016, orders have been issued dropping further action against Sri S. Ratnachari and others.

In the representation 5th read above, Sri S. Ratnachari has submitted that at 2. the time of preparing the panel of ADA's to the post of DDA during 2010-11 his name was mentioned at SI.No.57 and differed his candidature for promotion as DDA due to pendency of disciplinary cases vide G.O. 1s t read above and later his name was again differed for promotion to the post of DDA during the panel year 2011-12, on the same reason vide G.O. 2nd read above and during the above period his junior Sri S. Bapu Reddy, Sl.No.58 (Joined as DDA 12.01.2012), Balu Naik Sl.No.7 of (Joined as DDA 21.04.12) were considered for promotion and accordingly promoted to the post of DDA's during the panel years 2010-11 and 2011-12 respectively. Later he was promoted as DDA pending disciplinary case on adhoc basis and posted as DDA (PP) 0/o C&DA, AP and accordingly he was joined as DDA(PP) with effect from 01.12.2014 and discharge his duties continuously. Later the disciplinary case which was pending against him, was dropped vide Memo, Dt.21.03.2016. Sri S. Ratna Chari has, therefore, requested to consider his case for giving notional date of promotion on par with his junior Sri Bapu Reddy Sl. No.58 by fitting him in the panel year 2010- 11 in the cadre of Deputy Director of Agriculture with all eligible benefits.

3. In the letter 6th read above, the Director of Agriculture, A.P., has submitted as per the Final Integrated seniority list, Sri S. Ratnachari is at SI.No.34, whereas Sri N.Ch. Balu Naik is at SI.No.38 and Sri S. Bapu Reddy is at SI.No.44 vide proceedings dt:07.03.2014. He has further submitted that, Sri S. Ratnachari, DDA has requested to consider his case for giving notional date of promotion on par with his junior Sri Bapu Reddy (SI.No.58) vide GO Ms.No.31, Dt.26.02.2011 by fitting him in the

panel year 2010-11 in the cadre of DDA with all eligible benefits and issue appropriate orders. He has therefore, requested to issue necessary orders pertaining to regularization of promotion with fitment of notional benefits as requested by Sri S. Ratnachari, DDA.

4. In G.O.Ms.No.424, General Administration (Ser. C) Dept., dt.25.05.1976, Government have ordered that "in the event of there being an officer whose promotion has been recommended to be deferred, the vacancy that could have gone to the officer should be filled only on a purely temporary basis by the next person in the approved list of candidates for promotion. If the officer concerned is completely exonerated, he should be promoted to the post filled on a temporary basis, restoring him his rightful place in the list of promoted officers with retrospective effect".

4. Government after careful examination of the matter, hereby decided to consider the request of Sri S. Ratnachari, Deputy Director of Agriculture for notional promotion as Deputy Director of Agriculture on par with his junior Sri S. Bapu Reddy with effect from 21.01.2012 during the panel year 2010-11 with all consequential benefits notionally in terms of orders issued in G.O.Ms.No.424, dt.25.05.1976, as the disciplinary case pending against him was dropped.

5. Accordingly, Sri S. Ratna Chari is hereby promoted as Deputy Director of Agriculture notionally on par with his junior Sri S. Bapu Reddy with effect from 21.01.2012 during the panel year 2010-11 with all consequential benefits notionally in terms of orders issued in G.O.Ms.No.424, dt.25.05.1976, as the disciplinary case pending against him was dropped.

6. The Director of Agriculture, A.P., Guntur is requested to take further necessary action in the matter.
