**ORDER:-**

Under Rule 10(a) of the A.P. State & Subordinate Service Rules, 1996, Sri D. Venugopal, Assistant Director of Agriculture is hereby appointed by transfer on promotion to the post of Deputy Director of Agriculture during the panel year 2016-17 in the scale of pay of Rs.49,870/- – Rs.1,00,770/- plus usual allowances admissible under the rules in force from time to time.

2. Consequent on promotion, Government hereby post Sri D. Venugopal as Deputy Director of Agriculture (Agro), Office of the Joint Director of Agriculture, Kadapa, in the existing vacancy.

4. The individual should join the promotion post of Deputy Director of Agriculture (Agro), Office of the Joint Director of Agriculture, Kadapa, within 15 days from the date of receipt of this order. If he fails to join or evade joining by applying for leave or otherwise, within the stipulated time, he shall forfeit all his rights both for the present and future for the post of Deputy
