# ORDER:-

It is proposed to hold an enquiry against the said Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa in accordance with procedure laid down in Rule- 20 of the Andhra Pradesh Civil Services (Classification, Control and Appeal) Rules, 1991.

- 2. The substance of the imputations of misconduct or misbehavior in respect of which the enquiry is proposed to be held is set out in the enclosed statement of Articles of Charge (Annexure-I). Statement of imputation of misconduct or misbehavior on which action is proposed to be taken against him as Annexure-II, a list of documents by which and a list of witnesses by whom the Article of Charge is proposed to be sustained are also enclosed as Annexure-III and IV.
- 3. Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa is directed to submit a written statement of his defence within 15 days from the date of receipt of this G.O. and also to state whether he desires to be heard in person.
- 4. Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa is further informed that an Inquiry will be held only in respect of those articles of charge as are not admitted. He should therefore, specifically admit or deny the article of charge.
- 5. Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa is further informed that if he does not submit his written statement of defense on or before the date specified in para-3 above, further action will be processed based on the material available.
- 6. Attention of Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa is invited to Rule -24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to him under the Government. If any representation is received on his behalf from another person in

respect of any matter dealt with in these proceedings, it will be presumed that Sri Siva Ramakrishna Reddy, the then Mandal Agriculture Officer, chapadu and presently working as A.O (FCO)Lab, O/o DDA, (FTC) Kadapa is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of rule -24 of the A. P. Civil Service (Conduct) Rules, 1964.

### **ANNEXURE-I**

Statement Of Article Of Charge framed against Sri.Siva Ramakrishna Reddy, the then Mandal Agricultural Officer, Chapadu (M), presently working as Agricultural Officer, (FCO Lab) O/o D.D.A. (FTC), Kadapa, YSR District

## Article of Charge:I,

"That Sri Siva Ramakrishna Reddy, while working as Mandal Agricultural Officer, Chapadu (M) has failed to exercise effective supervision over the activities of Agro Rythu Seva Kendram, Chapadu (M), and Farmers Service Co-Operative Society Limited (FSCS), Alladupalli, Chapudu (M), YSR District which leads to conducting business without valid Form-0, diverted the stocks of fertilizers to black market without supplying to the farmers, sold fertilizers to higher prices than MRP, Not maintained the records properly and violated clause 4 & 5 of Fertilizer Control Order 1985. Thus he has violated the Rule 3 of APCS (Conduct) Rules 1964)".

# **ANNEXURE-II**

Statement of imputations of misconduct or misbehaviour in support of the articles of charge framed against Sri.Siva Ramakrishna Reddy, the then Mandal Agricultural Officer, Chapadu (M), presently working as Agricultural Officer, (FCO Lab) O/o D.D.A. (FTC), Kadapa, YSR District

It is brought to the notice of the undersigned by the Director General (Vigilance & Enforcement Department) Vigilance Report No.103 (C.No.196/V&E/D1/2015) DATED 23.10.2017 that on the petition of Sri Putta Sudhakar Yadav, TDP incharge, Mydukur Mandal, YSR District on mis-utilization of fertilizers of Agro Rythu Seva Kendram, Chapadu (M) and Farmers Service Co-Operative Society Limited (FSCS), Alladupalli, Chapudu (M), YSR District. The officials of Vigilance and Enforcement Department inspected the said premises and found the following irregularities:

- i) The Form "O" (Source of supply of fertilizers) of MARKFED is valid upto November 2014.But fertilizers were supplied to Agro Rythu Seva Kendram, Chapadu (M) and Farmers Service Co-Operative Society Limited (FSCS), Alladupalli, Chapudu (M) even after expiry of validity, without valid Form 'O'.
- ii)A.P. Markfed supplied 1047 MTs of Urea. But the Agro Rythu Seva Kendram, Chapadu (M) has shown only 886 MTS in the Stock Register and the balance 161 MTs was not entered in the records and the same was diverted to black market
- iii) The dealers sold the fertilizers to the farmers at higher prices than MRP.
- iv) Some of the signatures in the bill book of the Agro Rythu Seva Kendram, were actually not of the farmers.
- v) As per the entries in the stock Register, the MAO, Chapadu (M) had inspected the Agro Rythu Seva Kendram, premises in the month of November 2014. But,he had not detected and recorded any irregularities in the Stock Register.
- vi) The signatures of the farmers were not obtained on the bill books of Farmers Service Co-Operative Society Limited (FSCS), Alladupalli which are mandatory as per the clause 5 of FCO 1985.
- vii) Farmers Service Co-Operative Society Limited (FSCS) stored fertilizer without including the IPL Company From-0 in the Fertilizer's License.

viii) Farmers Service Co-Operative Society Limited (FSCS) has issued 802 bags of fertilizers to 193 farmers on the basis of pass books and shown same pass book number 143514 against the names of 193 farmers and also another set of pass books with Nos.163514, 143516, 1014015, 23445, 141514, 141501 and 414516 repeatedly shown in the distribution register. Thus the firm has shown bogus entries in the distribution registers and diverted the fertilizers to the black market.

But, Sri. Siva Ramakrishna Reddy, while working as MAO, Chapadu (M) failed to exercise effective supervision over the activities of Agra Rythu Seva Kendram, Chapadu (M) and Farmers Service Co-Operative Society Limited (FSCS), Alladupalli which is his core duty of MAO which cannot be kept aside at any cost, because interests of the farmers are involved in it. Thus he has failed to exercise the effective supervision over the activities of Agro Rythu Seva Kendram and Farmers Service Co-Operative Society Limited (FSCS), Alladupalli and violated clause 4 & 5 of Fertilizer Control Order 1985 and also APCS (Conduct) Rules 1964.
