candidate in the new State and forego seniority in the existing State as well as lien in terms of the instructions issued in the Circular Memo. 1<sup>st</sup> read above.

I) Department, Government of Telangana, Hyderabad is requested to issue necessary instructions to the Commissioner of Agriculture, Government of Telangana, Hyderabad to relieve the individual with immediate effect with a direction to report before the Special Chief Secretary to Government (FAC), Agriculture & Cooperation (Agri. I) Department, A.P. Secretariat, Velagapudi.
- 6. The Special Commissioner of Agriculture, A.P., Guntur / the Commissioner of Agriculture, Government of Telangana, Hyderabad shall take further necessary action in the matter accordingly.
