The Special Commissioner of Agriculture, Andhra Pradesh, Guntur has further stated that the both AEOs are requested for mutual transfers and willing to work in the respective States as per guidelines issued in the Circular Memo $1^{\rm st}$ read above and they does not have any disciplinary cases pending against them.
- 3. The Agriculture & Co-operation Department, Govt. of Telangana vide G.O. 3rd read above have issued orders for Inter-State transfer of Smt. K. Suvarna, AEO, Kottangoor Mandal, Nakrekal Division, Nalgonda District from the State of Telangana to the State of Andhra Pradesh in lieu of Sri G. Govt. of Andhra Pradesh have no objection to take the services of Smt. K. Suvarna, AEO to work in the State of Andhra Pradesh.

The Special Commissioner of Agriculture, Andhra Pradesh, Guntur shall take necessary action in the matter accordingly to relieve Sri Gangula Ravi Yadav, AEO, Orvakal (Mandal), Nandikotkur (Sub-Division), Kurnool District, A.P. to the State of Telangana, so as to report before the State of Telangana.
- 6. The individuals effected in this Inter-State transfer are not entitled for any Travelling Allowance or Dearness Allowance as per the guidelines issued in the Circular Memo $\mathbf{1}^{\text{st}}$ read above, as the transfer is ordered as per their request.
