O R D E R:-

In the G.O. 1st read above, orders were issued approving the Demerger proposal in respect of the A.P. Cooperative Oilseeds Growers’ Federation Ltd., and requested the Vice Chairman & Managing Director, A.P. Oilfed to take further necessary action for registration of new entity in the successor States by constituting Board of Directors and apportionment of Assets and Liabilities between the States as per the approved demerger plan and as per the provisions of the A.P. Cooperative Societies Act, 1964. In the G.O. 2nd read above, orders were issued constituting the Committee of Persons-in-Charge to the A.P. Cooperative Oilseeds Growers’ Federation Limited as detailed in the above said G.O., to manage the affairs of the Federation until further orders.

2. The Vice Chairman & Managing Director, A.P. Cooperative Oilseeds Growers’ Federation Limited, Vijayawada has submitted that the AP OILFED has submitted the mutual consent letter after Board approval, to the Expert Committee, Division of Employees, as per section 82 of the A.P. Reorganisation Act, 2014, the body corporate of A.P. Cooperative Oilseeds Growers’ Federation Ltd., (APOILFED) has completed the distribution of employees between the two successor, Federations namely A.P. OILFED and TS OILFED. He has also submitted that as per Section 82 of the A.P. Reorganisation Act, 2014 and based on operational convenience, the body corporate of A.P. Cooperative Oilseeds Growers’ Federation Ltd., (APOILFED) has completed the distribution of employees between the two successor Federations viz., APOILFED and TSOILFED and the same was brought to the notice of the Expert Committee and the Chair-Person & Members of the Expert Committee have endorsed the same.

3. Accordingly, the Government after careful examination of the matter, hereby approve the division of employees between the two successor Organizations viz., A.P. Cooperative Oilseeds Growers' Federation Limited and T.S. Cooperative Oilseeds Growers' Federation Limited as per Section 82 of the A.P. Reorganisation Act, 2014 and as confirmed by the Expert Committee.

4. The Vice Chairman & Managing Director, A.P. Cooperative Oilseeds Growers' Federation Ltd., Vijayawada shall take immediate further necessary in the matter accordingly.
