O R D E R:-

In the G.O. first read above, adhoc rules were issued in respect of Agricultural Officers and as per rule 4 of the said rules, no person shall be eligible for appointment by transfer unless the individual has put in not less than 3 years of service in the category from which appointment by transfer is made.

- 2. In the G.O. second read above, an adhoc rule was issued that "not withstanding anything contained in the relevant Special Rules for the State and Subordinate Services and in supersession of the Ad-hoc rule issued in relation to prescribing minimum service for promotion/appointment by transfer, no member of service is eligible for promotion/appointment by transfer from the lower category, class or grade, to the next higher category, unless he has put in not less than two years service in such lower category, class or grade".
- 3. In the reference third read above, the Special Commissioner of Agriculture, Andhra Pradesh has submitted proposal to amend rule 4 of the Adhoc Rules for the post of Agriculture Officer, reducing minimum service from three years to two years for promotion / appointment by transfer in tune with the orders issued in G.O. second read above.
- 4. Accordingly, the following Notification will be published in the Extraordinary Issue of Andhra Pradesh Gazette, dated 23.09.2019.

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling the Governor of Andhra Pradesh hereby makes the following amendment to the Adhoc Rules for the post of Agriculture Officer issued in G.O.Ms.No.16, Agriculture and Cooperation (FP.I) Department, dated the 21st January, 2000, as subsequently amended from time to time:-

AMENDMENT

In the said rules, in rule 4, for the expression "not less than 3 three years of service", the expression "not less than (2) two years of service" shall be substituted.
